Mr. Ricklic said that according to the Auditor and the Service Director the money is in place for the purchases of the plow trucks and the garbage truck.

Mr. Ricklic said the next matter to come before Committee is Resolution 16-2019 regarding the lease agreement for the cell tower which is located behind the police station.

Mr. Ricklic said this was not done in proper order. The proposal should have gone before Council before the agreement was signed by the Mayor. The moneys received, which is Approximately \$800 a month for the tower, what are they earmarked for?

Service Director McAbier responded that they'll go in the General Fund.

Mayor Day suggested that some of the money could be put in a fund for façade improvements downtown. He noted that would require a separate piece of legislation.
