#### **Administrative Reports.....**

# MAYOR'S REPORT/REQUESTS ....MAYOR JOEL B. DAY Mayor Day had the following report:

- There is another Health Emergency in New Philadelphia: Drug Overdoses: Last Thursday I received from alarming statistics in a report from Wes Halter, the Fire Department's Emergency Medical Services Coordinator. He is also a member of the Tuscarawas County Quick Response Team. Included in his QRT report was a report from the Tuscarawas County Coroner that showed a 283% increase in drug overdose deaths in our county since 2017. This year alone there have been 17 reported deaths in the county. Our City Health Department says that 10 of those deaths occurred here. Also, The QRT report showed that New Philadelphia leads Tuscarawas County in the number of reported drug overdoses. Over the past two years New Philadelphia has had 97 drug overdoses, Uhrichsville 30 and Dover 26. The Quick Response Team was created to try to steer drug abusers and overdose victims into treatment programs. The report indicated that the synthetic opioids fentanyl and carfentanil were the leading cause of the drug overdose deaths. And methamphetamine was the drug of choice for abusers in New Philadelphia and Tuscarawas County. The COVID-19 pandemic is likely playing a role in creating rise in drug overdose deaths this year. People are turning to drugs to cope with the stress and uncertainty. But the fact is that this problem has been plaguing our community for several years. And it's time to confront it. I'm asking for help from all New Philadelphia residents and businesses. If you know of someone suffering from drug addiction and abuse, contact the City Health Department to learn how to get them on a path to recovery. If you know of drug dealers or places where drug dealing is occurring, contact the New Philadelphia Police Department. One step that the City can take to fight this battle is to hire additional police officers. According to Chief Goodwin, the level of staffing in the Police Department has not increased in at least 20 years. We need a detective that is dedicated solely to drug cases. I'll ask Council president Kemp to assign this need to the Finance Committee for study. We can no longer think that solving this is somebody else's problem. It's our problem. And it's up to us to solve it.
- Governor Dewine's Mandate to Wear Facial Coverings in Public: I encourage all New Philadelphians to follow Governor Dewine's statewide mandate that requires all of us to wear a facial covering in public places. If simply wearing a mask while shopping and in crowded places helps bring this pandemic to an end sooner than later, let's do it. Any complaints about the mask mandate should be directed to the City Health Department, not the Police Department.
- Alley Cats "Starry Night" Mural Adds to the Downtown Arts Movement: If you haven't done so already, stop by Alley Cats Marketplace on Allen Lane SW downtown to view "Starry Night", the latest work in progress by local mural artist Jon Stucky. He was commissioned by Alley Cats owner Debbie Knisely to paint the mural on the south wall of the building. The mural is a spinoff of Vincent Van Gogh's famous "Starry Night" painting. Stucky has included several local twists to the mural. Visual art helps enhance the appearance of our downtown area and is something I will continue to encourage.
- ➤ Have You Completed your U.S. Census Form? : Please do. The data it provides helps send federal dollars back to New Philadelphia to fund projects that strengthen our community.

SERVICE DIRECTOR......MR. RON MCABIER

We had a preconstruction meeting last week for the CDBG Project with Mid Ohio Contracting. He will be in August 5<sup>th</sup>. He believes it will take four weeks to complete that project.

SAFETY DIRECTOR .....MR. GREG POPHAM

In the police department they have received official notice from the New Philadelphia Civil Service Commission on a Sergeant's promotional test that was given several months ago. Tomorrow the Mayor will be swearing in Tessa Pohovey as the Police Department's new Sergeant. In the fire department I would like to turn over the rest of my time to Chief Parrish to talk about the Pulse Point Program.

#### Fire Chief Jim Parrish had the following report:

As you remember last Council Meeting I talked to you a little bit about the Pulse Point Program. The program costs approximately \$10,000 and we had received a \$5,000 grant from the Marsh Foundation. Since then, on Friday I had received a phone call and an anonymous donor came and donated \$3,000 and Saturday I had received a donation of \$2,000 in memory of Raymond and Patricia Ricklic from the Ricklic family. It will be probably about 4 to 6 weeks before we implement it and I'll have more information for you at that time.

LAW DIRECTOR . . . . . . . . MR. MARVIN FETE

Mr. Fete had the following report:

I'd like to spend my time this evening elaborating on the City's policy on mask enforcement. As everyone is aware Governor DeWine issued a statewide mandate on July 23, 2020 that everyone wear masks while at a public place. The City is unique because we have our own Health Department. I know many of us are thankful for that. I've consulted with both Vickie Ionno and the New Philadelphia Police Chief and I've reviewed the order myself. Health orders are enforced by the local Health Department. They are also the body that is responsible for dealing with statewide health orders. The New Philadelphia Police Department and our local Sheriff's Office are not the "mask police". Law Enforcement officials in our area have more than enough to deal with in crime and the very real threat of drugs in our community. Please do not call your local law enforcement offices to register a complaint regarding masks., instead direct complaints to your local Health Department. Our Health Department has done an outstanding job at the height of this pandemic to reduce the curve to allow us to reopen safely. I am fully confident they will handle complaints regarding masks and find the best solutions for everyone involved to keep our citizens safe and healthy during these challenging times. Law Enforcement Officers will be involved in situations where there are altercations due to masks, as businesses have the right to deny entrance to a private property if you are not wearing one. Should someone become belligerent or refuse to leave in that type of situation. Then it is elevated beyond the issue of simply wearing a mask to possible criminal disorderly conduct or trespass. That is something that would require the attention of the police. Having lived in this community my entire life and witnessed how we have responded in this crisis so far I'm hopeful that will not be necessary. I also want to echo what the Mayor said. I want to encourage people to wear masks and be good citizens so we can keep our businesses and schools open. These days all of us need to rely on what Abraham Lincoln called the "better angels of our nature". No one thinks twice about covering their mouth when they cough or turning their head when they sneeze. As the President has said wearing a mask is patriotic. It is also temporary and our best defense until there is a vaccine. Each of us has a duty to protect our elderly and vulnerable populations during these challenging times, and I ask that we do that as citizens.

I ran past a house earlier today that had a sign on their front door that said "Quarantined". If people are quarantined do they put signs like that up or is that just

To my knowledge that's not something that we're doing. Actually we go out of our way to avoid that because you don't want to single people out. Our goal in alerting the individual that's been quarantined is to make sure that their privacy is protected. So that would be something that the individual homeowner would choose to put on their door.

They left big ruts because the ground was soft. I asked Scott the Water Supt. why they did it without my permission. He said he doesn't have time to find out who owns the property. The project they were doing had nothing to do with my property. They could have dug the hole on the street by parking on the street. I turned an invoice in 3 months ago and have never been paid. I expect to be reimbursed.

The Anti Drug Coalition is comprised of members of the Community. I actually go to those meetings. There's a number of sectors that they have to have represented such as businesses, churches, and professionals that work in the field.

## Mr. Maurer had the following comment:

I had the chance to represent the City because the Mayor was out of town and President Kemp had an obligation. I got to represent the City for Buckeye Boys and Girls State. I was warned to dress cool, no air conditioning that I know of and we were wearing masks during this 2 hour program. I got to listen to the speakers from American Legion. One guy was hit by a SCUD missile in Iran and one guy was a Vietnam veteran. It really put into perspective what a small gesture wearing a mask is.
