NEW PHILADELPHIA CITY COUNCIL MET IN REGULAR SESSION IN COUNCIL CHAMBERS ON JANUARY 13TH, 2014 WITH PRESIDENT OF COUNCIL, SAM HITCHCOCK, PRESIDING.

MR. HITCHCOCK OFFERED A PRAYER, AND ALL IN ATTENDANCE RECITED THE PLEDGE OF ALLEGIANCE.

PRESIDENT OF COUNCIL, SAM HITCHCOCK WELCOMED THE NEW MAYOR, DAVID JOHNSON THE CITY'S FIRST LADY, MRS. NANCY JOHNSON, THE NEW TREASURER MR. AARON HILLYER, AND THE NEW COUNCIL PERSON MRS. CHERYL RAMOS.

COUNCIL MEMBERS IN ATTENDANCE:

MS. SANDY COX MR. DAN LANZER MR. DARRIN LAUTENSCHLEGER MR. ROB MAURER MRS. CHERYL RAMOS MS. WINNIE WALKER MR. JOHN ZUCAL

PRESIDENT OF COUNCIL, SAM HITCHCOCK ANNOUNCED THAT THE LAW DIRECTOR, MARVIN FETE IS ABSENT FROM TONIGHT'S MEETING.

MS. COX MADE A MOTION TO ACCEPT TONIGHT'S AGENDA MR. LANZER SECONDED THE MOTION.

ROLL CALL 7 YEAS MOTION PASSED

APPOINTMENT OF THE CLERK OF COUNCIL FOR THE PERIOD 2014 THROUGH 2017:

THE PRESIDENT OF COUNCIL, MR. SAM HITCHCOCK ANNOUNCED THAT NOMINATIONS ARE IN ORDER FOR THE POSITION OF CLERK OF COUNCIL. COUNCIL MEMBER JOHN ZUCAL NOMINATED MS. PATRICIA MCKAY TO RETURN AND TO SERVE THE CITY COUNCIL AS CLERK MS. COX SECONDED THE MOTION

THE PRESIDENT OF COUNCIL, MR. SAM HITCHCOCK ASKED IF THERE WERE ANY OTHER NOMINATIONS. BEING THERE WERE NO FURTHER NOMINATIONS THE PRESIDENT OF COUNCIL, MR. SAM HITCHCOCK CLOSED THE NOMINATIONS.

THE PRESIDENT OF COUNCIL, MR. SAM HITCHCOCK ASK FOR A MOTION TO ACCEPT MS. PATRICIA MCKAY AS CLERK MS. COX MADE THAT MOTION AND MS. WALKER SECONDED VOTE WAS TAKEN BY A VOICE COUNT. ALL WAS IN FAVOR AND NO COUNCIL MEMBER WAS OPPOSED. MS. PATRICIA MCKAY WAS REAPPOINTED COUNCIL CLERK.

THE PRESIDENT OF COUNCIL, MR. SAM HITCHCOCK CONGRATULATED THE CLERK. THE CLERK THANKED EVERYONE FOR THE REAPPOINTMENT.

THE PRESIDENT OF COUNCIL, MR. SAM HITCHCOCK ANNOUNCED THAT THE COMMITTEE ASSIGNMENT LIST FOR 2014 THROUGH 2015 WAS DISTRIBUTED TO ALL COUNCIL MEMBERS PRIOR TO THIS COUNCIL MEETING. THE PRESIDENT OF COUNCIL, MR. SAM HITCHCOCK INFORMED COUNCIL THAT TWO YEARS AGO WHEN HE FIRST PREPARED THE LIST HE TALKED WITH EVERYONE AND TRIED TO MAKE THE APPOINTMENTS SATISFY EVERYONE AND TO GET THE JOB DONE. IT WAS A LOT EASIER BACK THEN. A MOTION WAS MADE AND SECONDED AND IT WAS PASSED THE PRESIDENT OF COUNCIL, MR. SAM HITCHCOCK STATED THAT HE IS NOT ANTICIPATING THAT TO HAPPEN TONIGHT. THE PRESIDENT OF COUNCIL, MR. SAM HITCHCOCK INFORMED ALL THIS IN NOT SOMETHING HE PUT TOGETHER IN FIVE MINUTES HE LOOKED AT ALL SITUATIONS AND PUT TIME IN THIS WHEN HE PUT THE COMMITTEE ASSIGNMENT TOGETHER IT WAS FOR THE OPPORTUNITY FOR THE CITIZENS THE COMMITTEE AND COUNCIL PEOPLE TO BEST REPRESENT THE DIFFERENT AREAS WE HAVE TO DEAL WITH.

AND WITH THAT HE EXERCISED THE MOTION ON THE FLOOR FOR THE COMMITTEE ASSIGNMENT LIST FOR 2014/2015 BE ACCEPTED.

MR. JOHN ZUCAL MADE A MOTION TO ACCEPT THE COMMITTEE ASSIGNMENTS AS WAS PRESENTED BY THE PRESIDENT OF COUNCIL, MR. SAM HITCHCOCK IN THE DRAFT DOCUMENT TO EACH OF THE COUNCIL MEMBERS.

MR. LAUTENSCHLEGER SECONDED THE MOTION

THE PRESIDENT OF COUNCIL, MR. SAM HITCHCOCK: ASKED IF THERE WAS ANY DISCUSSION.

MS. COX:

ONLY IF WE DO NOT APPROVE THEM DO THE ASSIGNMENTS REVERT BACK TO 2012 ASSIGNMENT LIST?

THE PRESIDENT OF COUNCIL, MR. SAM HITCHCOCK:

THE INSTRUCTIONS FROM THE LAW DIRECTOR HAS ADVISED THE PRESIDENT TO TRY TO EXPEDITE THE PROCESS OF GETTING NEW COMMITTEE APPOINTMENTS IN PLACE BUT IN THE EVENT IF THAT DOES NOT TAKE PLACE TONIGHT THE PRIOR COMMITTEE APPOINTMENTS AS THEY STAND WILL BE IN EFFECT. THAT WOULD INCLUDE MRS. RAMOS FILLING THE CHAIR OF MS. ESPENSCHIED.

COMMENTS FROM COUNCIL MEMBER MR. JOHN ZUCAL:

SO THOSE REVERTED COMMITTEE ASSIGNMENTS WOULD HAVE TO BE APPROVED AS WELL? WHATEVER THE ASSIGNMENTS THEY WOULD BE THE NEW ASSIGNMENTS. WHAT MR. ZUCAL UNDERSTANDS THE LAW IS ALL STANDING COMMITTEES NEED TO BE APPROVED BY THE MEMBERS OF COUNCIL IN RESPECT OF THE CITIZENS OF NEW PHILADELPHIA?

I WOULD ENTERTAIN THE THOUGHT IF WE REVERTED TO 2012 THOSE ALSO WOULD HAVE TO BE APPROVED.

OUR ORDNANCE DOES STATE, STANDING COMMITTEES ASSIGNMENTS MADE BY THE PRESIDENT OF COUNCIL HAVE TO BE APPROVED BY MEMBERS OF COUNCIL.

COMMENTS FROM COUNCIL MEMBER MR. DAN LANZER: THOSE WERE APPROVED IN 2012

COMMENTS FROM COUNCIL MEMBER MR. JOHN ZUCAL:

UNFORTUNATELY THEY WERE APPROVED IN 2012

WITHOUT THE LAW DIRECTOR BEING HERE I WOULD LIKE TO HAVE A LEGAL INTERPRETATION

THE PRESIDENT OF COUNCIL, MR. SAM HITCHCOCK READ AN E-MAIL RECEIVED FROM THE LAW DIRECTOR:

"IN THE EVENT COUNCIL FAILS TO APPROVE THE ASSIGNMENTS IT WOULD FALL ON THE THE PRESIDENT OF COUNCIL, MR. SAM HITCHCOCK TO COME UP WITH NEW ASSIGNMENTS. COUNCIL DOES NOT HAVE THE AUTHORITY TO MAKE AMENDMENTS ON TH FLOOR TO THE THE PRESIDENT OF COUNCIL, MR. SAM HITCHCOCK PROPOSED COMMITTEE LIST. THEY CAN ONLY VOTE TO APPROVE OR NOT APPROVE.

DURING THE INTERIM OF A NO VOTE ON THE NEW ASSIGNMENTS

COUNCIL DOES NOT COME TO A STOP

THEY WOULD MERELY REVERT BACK TO THAT WAS VOTED ON BY COUNCIL IN 2012 ANY NEW MEMBER WHETHER APPOINTED OR ELECTED SHALL TAKE THE ASSIGNMENT OF THEIR PREDECESSOR UNTIL SUCH TIME THE PRESIDENT OF COUNCIL, MR. SAM HITCHCOCK MAKES NEW ASSIGNMENT A SIMPLE MAJORITY OF APPROVAL OF COUNCIL."

COMMENTS FROM COUNCIL MEMBER MR. JOHN ZUCAL:

MR. ZUCAL THAT WAS HIS INTERPRETATION THAT HE HAD WITH AUTHORITIES AND FRIENDS IN COLUMBUS AS WELL.

ALTHOUGH IT REVERTS BACK, AS PRESIDENT YOU HAVE THE RIGHT TO FURTHER APPOINT AND TRY TO RESTRUCTURE THOSE COMMITTEES FOR 2014.

PRESIDENT OF COUNCIL, MR. SAM HITCHCOCK: IF THESE ASSIGNMENTS ARE NOT APPROVED TONIGHT, BUSINESS DOES NOT STOP. WE HAVE THE ABILITY TO CARRY ON BUSINESS UNDER THE OLD ASSIGNMENT LIST.

Motion was made by Mr. John Zucal to approve the 2014/2015 Assignment List Motion was seconded by Mr. Darrin Lautenschleger Roll Call 3 yeas 4 nays (Ms. Cox, Mr. Lanzer, Mrs. Ramos and Ms. Walker) Motion failed

REQUEST FROM COUNCIL MEMBER MR. JOHN ZUCAL FOR COUNCIL MEMBERS WHO VOTED NO TO EXPLAIN WHY THEY VOTED NO.

COUNCIL MEMBER MS. COX:

SHE DIDN'T HAVE ANY OBJECTIONS TO THE 2014 LIST PER SE BUT JUST WANTED THE 2014 LIST TO BE THE SAME AS THE PREVIOUS ASSIGNMENT LIST.

COMMENTS FROM COUNCIL MEMBER MR. JOHN ZUCAL:

COUNCIL MEMBER MR. MAURER IS A VETERAN MEMBER OF COUNCIL WITH OVER 14 YEARS EXPERIENCE AN HOLDS A MASTERS DEGREE IN BUSINESS ADMINISTRATION AND IS VICE PRESIDENT WITH ONE OF OUR LOCAL FINANCIAL INSTITUTIONS.

THE CITIZENS OF NEW PHILADELPHIA WOULD BENEFIT BY HIS QUALIFICATIONS RATHER THAN SOMEONE WHO IS NEW TO COUNCIL, NO DISREGARD FOR MRS. RAMOS, WHO CAN BEST ACT ON THE CITY OF NEW PHILADELPHIA. WHO CAN BEST ACT ON THE CITY OF NEW PHILADELPHIA OBVIOUSLY MR. MAURER IS A HIGHLY QUALIFIED MEMBER OF COUNCIL

TO BE A PART OF THE FINANCE COMMITTEE.

PRESIDENT OF COUNCIL, MR. SAM HITCHCOCK:

THE REASON I PUT MR. MAURER IN THAT POSITION WAS FOR EXACTLY THOSE REASONS BEST REPRESENT THE COMMUNITY. WITH THE BEST PEOPLE THAT ARE QUALIFIED TO HOLD PARTICULAR POSITIONS ON THOSE COMMITTEES AND I GAVE WITH YOUR NOTHING PERSONAL WITH MRS. RAMOS I FEEL SHE WILL HAVE A LOT TO OFFER THE CITY OF NEW PHILADELPHIA AS A COUNCIL PERSON BUT AS A NEW PERSON ON COUNCIL I JUST THINK WE SHOULD CHOOSE WHAT WE KNOW IS THE BEST CHOICE FOR A PARTICULAR POSITION. YOU LISTED MR. MAURER'S OBVIOUS CREDENTIALS AND HIS LONGEVITY ON CITY COUNCIL. MY CHOICE HE WAS THE BEST FOR THAT POSITION.

MS COX:

IT HAS NOTHING TO DO WITH ANYONE IN THIS ROOM I JUST WANT TO KEEP THE LIST THE SAME NOTHING TO DO WITH ANYONE PERSONALLY.

THE PRESIDENT OF COUNCIL, MR. SAM HITCHCOCK: I WAS NOT THE ONE WHO APPOINTED MR. ZUCAL: UPON MY ELECTION I WAS NAMED CHAIR OF SPECIAL/CONTACT MR LANZER'S ELECTION THAT CHANGED NO LONGER A MEMBER SPECIAL/CONTACT BUT OF SALARY. TO SAY THAT THESE ARE ALWAYS MAINTAINED FROM YEAR TO YEAR IS NOT TRUE.

THE PRESIDENT OF COUNCIL, MR. SAM HITCHCOCK: MS. WALKER WHAT WAS YOUR REASON FOR THE NO VOTE? I WANT TO KEEP IT AS IT IS. I DO BELIEVE THAT MRS. RAMOS CAN LEARN AND WE NEED TO HAVE SOMEONE LIKE THAT. I THINK SHE IS WELL QUALIFIED. SHE DOESN'T BRING ANY BAGGAGE EITHER. SHE HAS A LOT TO OFFER AND BRINGS A LOT WITH HER.

COMMENT FROM MR. LANZER:

NOT ALWAYS THE CASE I WAS APPOINTED TO THE SALARY COMMITTEE WITH NO SALARY EXPERIENCE.

MR. LANZER WHAT WAS YOUR REASON FOR THE NO VOTE?

MR. LANZER SAID HE ECHOED WHAT MS. COX AND MS. WALKER SAID NO OFFENCE TO MR. MAURER I THINK HE WOULD DO A FINE JOB ON THE FINANCE COMMITTEE.

I THINK WE SHOULD KEEP THE COMMITTEE AS THEY WERE

IT WOULD BE A GOOD LEARNING EXPERIENCE FOR MRS. RAMOS TO BE ON THE COMMITTEE WITH MS. COX AND MR. LAUTENSCHLEGER.

MRS. RAMOS: (THE OBJECT OF THE DISCUSSION):

WHAT WAS YOUR REASON FOR THE NO VOTE?

PART OF MY REASON FOR RUNNING FOR CITY COUNCIL WAS TO SCRUTINIZE THE BUDGET LIKE I DO MY OWN AND TO ENCOURAGE THE CITY AS MUCH AS I COULD TO BALANCE THE BUDGET.

THE PROBLEM IS WE ARE FACING A BIG PROBLEM WITH THE BUDGET. YOU'VE SEEN IT COMING PERSONALLY FOR FIVE OR SIX YEARS.

THE YEAR I'VE SET IN THE COUNCIL MEETING HERE WITH NO DISRESPECT TO ANYONE NOTHING WAS DONE ABOUT THE CLIFF WE ARE FACING OR WE MIGHT ALREADY BE GOING OVER. SO THAT IS WHY I VOTED NO.

I THOUGHT THAT I COULD BRING A FRESH PROSPECTIVE

I HAVE NO BAGGAGE I OWE NO ONE ANYTHING SO

I WOULD BE ADVOCATING FOR THE TAXPAYER.

MR. ZUCAL:

I THINK WE ALL ADVOCATE FOR THE TAXPAYER.

COMMENTS FROM MR. MAURER:

I AM NOT GOING TO POLITIC, WE ARE FACING THE MOST DIFFICULT TIME IN THE CITY OF NEW PHILADELPHIA'S HISTORY AND

I THINK MY EXPERIENCE ON COUNCIL ALONG WITH MY FINANCE BACKGROUND

I THINK I CAN DO A GOOD JOB.

I THINK THIS IS IMPORTANT

I DON'T THINK IT SHOULD BE A LEARNING POSITION.

AT THIS POINT WE NEED TO DO SOMETHING.

COMMENT FROM MS. COX:

I EXPECT YOU TO BE AT THE MEETINGS ALL COUNCIL MEMBERS CAN BE THERE.

THE PRESIDENT OF COUNCIL, MR. SAM HITCHCOCK:

THE SIMPLE MAJORITY HAS RULED

THE MOTION HAS FAILED

I WOULD ENTERTAIN A MOTION TO AGAIN ACCEPT COMMITTEE ASSIGNMENTS AS THEY WERE IN 2012 WITH REPLACING COLLEEN ESPENSCHIED WITH MRS. RAMOS.

COUNCIL MEMBER MR. DAN LANZER: MADE A MOTION TO ACCEPT THE 2012 LIST ASSIGNMENTS MS. COX SECONDED THE MOTION DISCUSSION:

MR. LAUTENSCHLEGER: ENCOURAGED THE PRESIDENT TO GO BACK AND REVIEW THOSE. YOU JUST READ TO COUNCIL AN E-MAIL FROM THE LAW DIRECTOR IF THE COMMITTEE CAN'T BE APPROVED OBVIOUSLY THE BUSINESS CAN CONTINUE UNTIL SOME UPDATES HAVE BEEN MADE. MR. LAUTENSCHLEGER ENCOURAGED: ALL OF COUNCIL TO PUT OUR THOUGHTS IN WRITING AND SUBMIT THEM TO THE PRESIDENT SO WE CAN ALL SEE THEM TO SEE IF WE CAN REACH SOME COMMON GROUND. BIGGEST PROBLEM WE NEED TO REACH SOME COMMON GROUND. COMMENT FROM MR. ZUCAL:

I ECHO WHAT MR. LAUTENSCHLEGER SAID

WE OWE IT TO THE TAXPAYERS, MORE THAN EVER THAT THOSE ASSIGNMENTS ARE NOT BASED ON HISTORY.

I DON'T KNOW WHAT HISTORY GAINS US EXCEPT A DEFICIT RATHER THAN BRING A HEALTHY PROSPECTIVE BASED ON SOMEBODY THAT HAS THE QUALIFICATIONS.

MR. MAURER DOES NOT WANT TO POLITIC FOR HIMSELF.

I WOULD HAVE A HARD TIME TO EXPLAIN TO THE CONSTITUENTS CITIZENS OF WARD TWO OF NEW PHILADELPHIA AS WELL AS ALL THE CITIZENS AND HOW AN INDIVIDUAL WAS APPOINTED TO A FINANCE COMMITTEE THAT HOLDS AN MBA, WITH YEARS OF EXPERIENCE ON COUNCIL AND REPRESENTS ONE OF OUR FINANCIAL INSTITUTES IS NOT HIGHLY QUALIFIED THAT WOULD NOT BE ONE OF THE BEST INDIVIDUAL TO SERVE ON THAT COMMITTEE.

MR. MAURER DID STATE THE FINANCE COMMITTEE, BEING WHERE WE ARE AT, IT IS NOT A TRAINING GROUND FOR ANYONE.

MR. ZUCAL:

I THINK THAT PUTS MRS. RAMOS AT AN UNFAIR POSITION THAT SHE HAS ZERO EXPERIENCE ON CITY COUNCIL AND SHE DOES HAVE SOME VERY CLEAR GOALS WHICH CAN ALWAYS BE MET BY REPRESENTING THE WHOLE AND NOT NECESSARY ON THE COMMITTEE.

EACH PERSON HAS A RIGHT TO VOTE AS A WHOLE AND YOU CAN CERTAINLY CARRY OUT WHAT YOUR ASPIRATIONS ARE THE WAY YOU VOTE FOR THAT WHEN THINGS COME OUT OF COMMITTEE TO COUNCIL AS A WHOLE FOR A VOTE.

MS. COX:

THERE ARE FOUR PEOPLE ON THE FINANCE COMMITTEE. I WILL CONTACT EVERYONE AND TRY TO MAKE SURE, IF I'M THE CHAIRMAN, THAT EVERY ONE CAN ATTEND. ALL SEVEN MEMBERS NEED TO BE AT THAT MEETING AND BE AWARE OF WHAT IS GOING ON.

MRS. RAMOS:

I DON'T HAVE A MBA IN FINANCES BUT I HAVE SAT HERE DURING THE LAST YEAR IT IS VERY FRUSTRATING THE CITY COUNCIL DOES (NOTHING AGAINST ANYONE) AND HAS DONE NOTHING NO MATTER WHAT YOUR QUALIFICATIONS ARE THAT IS MY BIG CONCERN I WAS SETTING HERE FOR A YEAR AND NOTHING WAS DONE TO ADDRESS THE FINANCIAL SITUATION OF THE CITY. BUT YET COUNCIL PUT A LEVY ON THE BALLET TO INCREASE INCOME TAXES EVEN THOUGH THE TAXPAYERS ARE STRETCHED THIN, TO THE LIMIT. THAT FAILED BY 73%. THAT IS A CLEAR MESSAGE FROM THE TAXPAYER THE FISCAL HOUSE NEEDS TO GET IN ORDER. YES I'M THE NEW MEMBER MOST OF YOU HAVE BEEN HERE FOR A VERY LONG TIME AND I AGREE

MR. ZUCAL:

I AGREE I'VE HAD THAT SAME FRUSTRATION FOR OVER A YEAR.

I VOTED AGAINST THE BUDGET WHEN IT WAS PLACED ON THE AGENDA AND I'M THE SAME PERSON THAT VOTED AGAINST THE INCOME TAX ISSUE TO BE PLACED ON THE BALLOT. I ASK FOR A PLAN EVERY TIME I HEAR A NO VOTE.

WITH MR. ZUCAL IT IS TIME WE GET DOWN TO BUSINESS. WE GOT TO TAKE CARE OF THIS.

TELL ME WHAT WE ARE GOING TO DO TO CHANGE THINGS.

I HAD THE SAME INTEREST OF SERVING ON THE FINANCIAL COMMITTEE

MR. HITCHCOCK WHEN YOU WERE ASKING FOR INPUT FROM MEMBERS OF CITY COUNCIL AS TO VALUE THERE WOULD LIKE TO SERVE. I ASK FOR CONSIDERATION FOR PUTTING ME ON THE FINANCE COMMITTEE I DO WHAT TO SERVE AS PART OF THE CLEAR THERE ARE. A LOT FOLKS ON THAT ARE CONCERNED AS TO WHERE WE ARE AT. SHED LIGHT AND THOUGHT. I HAVE NOT SERVED ON THE FINANCE COMMITTEE AND STILL WOULD VALUE THAT

OPPORTUNITY.

THE PRESIDENT OF COUNCIL, MR. SAM HITCHCOCK:

THERE ARE SOME STRONG ATTITUDES AND OPINIONS BUT I HAVE A JOB TO DO.

ROLL CALL,

4 YEAS 3 NAYS (MR. LAUTENSCHLEGER, MR. MAURER, AND MR. JOHN ZUCAL.)

MOTION PASSED

SERVICE DIRECTOR......MR. JAMES ZUCAL

The Service Director reported on the following:

- Five Point Storm Sewer Project
 - Last Friday the contractor, Tucson, Inc.
 - Moved in to do the last portion of the Sanitary Sewer Line on Bank Lane,
 - That portion will be economically important because it is part of a job creation application package. When that is completed that area will have water and sewer available. There is some vacant ground in that area.
 - They hope to wrap that up in two weeks.
 - The Service Director reported that in the Spring the paving will be finalized.
 - The Service Director complimented our Service sector employees last week it was very difficult time because of the cold weather conditions. Every department handled it well. The Service Director particularly wanted to thank Ed Wilson and his crew who repaired two 6 inch water main breaks, three service line breaks and numerous shut offs. They have all done an exceptional job. The conditions were brutal. Working together the Street Department did an exceptional job as working as a team.
 - The Service Director provided a list of accomplishment s for last year (2013) to all Council and requested that everyone take a look at them.
 - The Service Director reported that he has been working closely with Mayor Johnson to bring him up to speed on all projects.

The Service Director reported that they have had a lot to talk about.

The Service Director stated that he is very excited about working with Mayor Johnson.

Comments from Council Member John Zucal

Commended the members of our Street Crews, Water Department, and the folks that are out there tonight. Those conditions were brutal. As a member of Council and a Citizen of New Philadelphia Council Member John Zucal stated that he appreciated the hard work those guys put in.

Sanitation, Water Department the Street Department whoever it was the Citizens of New Philadelphia were proudly served.

President of Council, Sam Hitchcock: Announced that he echoed the Comments from Council Member John Zucal.

President of Council, Sam Hitchcock mentioned his 9 days in office as Mayor

All the Departments were very helpful to him

Mr. Hitchcock mentioned that the power behind the throne was the Mayor's Assistant Mary Jo Fragasse. Ms. Fragasse is pleasant and very congenial.

President of Council, Sam Hitchcock reported that the City Departments work liked a well oiled machine.

Comments from Council Member John Zucal:

Thanked the Department Heads and stated that they are the backbone of those efforts. They utilize resources as best they can to see that is done.

President of Council, Sam Hitchcock: Requested that Council show their appreciation by giving a round of applause for their service.
