ADMINISTRATIVE REPORTS:

MAYOR'S REPORT MAYOR RON BRODZINSKI

Submitted a written report of the activities of the Mayor's office from January 15 through January 28, 2002. Reported that he attended a Bureau of Workers' Compensation meeting in Cambridge on January 16, and because of his attendance at that meeting, the city will receive a rebate check for \$34,000. Reported that an Insurance Board meeting was held January 17, and the city's insurance is expected to raise approximately 15%. Reported that he attended a Solid Waste District Policy Board meeting and presented the composting figures for 2001. Gave the second half of the 2001 State of the City Address. Mr. Houston asked Mayor Brodzinski to explain the figures and coverage for the city's health insurance. Mayor Brodzinski said currently the city pays approximately \$350 per employee, and they are covered for 80% of medical expenses after deductible, with some vision insurance.
