STANDING COMMITTEE REPORTS:

FINANCE COMMITTEE.....MS. SANDRA COX

Reported meeting Monday June 4, 2001 to discuss transfer of funds for Municipal Court. Ordinance 29-2001 was approved, and passage recommended. The 2002 Tax Budget was also discussed and approved. Ms. Cox reported that the purchase of a new garbage truck was already approved by Committee.

SALARY COMMITTEE MR. JIM LOCKER

Reported that he would like to see lists of those who should be considered for a raise, instead of singling out individuals. President of Council Dave Johnson said he would do that when he is aware of others in line for raises. He also assigned to the Salary Committee a request by Fire Chief Caton to set a salary for the position of Fire Prevention Officer, and asked that they review salaries of council members and the clerk.

SAFETY, HEALTH, AND SERVICE COMMITTEE MS. WINNIE WALKER

Reported that she is having a Work Session on Monday, June 18 at 6:00 p.m. to review the housing code ordinance. Mr. Johnson assigned a request by Safety Director Greg Popham for possible increase in fines for fines for parking in restricted parking spaces.

PUBLIC WORKS COMMITTEE. MR. JOEL DAY

Reported meeting tonight to discuss the Adelphia Cable rate increase. Although several questions were answered by a representative of Adelphia, the Committee will introduce legislation opposing the increase. Chapter 1131 of the Codified Ordinances was addressed, specifically dealing with the occupancy of multi-family dwellings. It was decided that the proposed housing code would better address this issue; but Mr. Cicconetti asked the Committee to look into requiring two entrances/exits and prohibiting conversion of converting single family homes into multi family homes. Mr. Johnson assigned the latter to the Public Works Committee for study. The Committee also addressed a problem of dirty water at a residence on Second St. S.E. Water Superintendent Kelly Ricklic, who was in attendance, said the solution would be costly waterline construction. The Committee approved having a cost estimate drawn up and introduced to Committee for recommendation.

Reported meeting June 4 to discuss Resolution 7-2001, which was approved. Also discussed was the Endres annexation, and they are requesting a tax abatement. The Committee would like to meet again to discuss this, so a meeting was scheduled for Monday, June 18 at approximately 8:00 p.m. Recommended passage of Resolution 11-2001.

Reported that Mr. Brad Swinderman will soon be bringing his results of ward re-apportionment to Council.

SPECIAL COMMITTEE. MR. TOM LOCKER NO REPORT

VISITOR'S COMMENTS:

Robert Foust, 323 Park Ave. N.W., New Philadelphia, complained that neighbors have built ramps for bicycles and skateboards and there is a problem now with trash being put into neighbors' yards, fires are being built in the yard, fighting among the boys, knife throwing, boys urinating in the yard, etc. He asked what the neighbors could do to take care of these problems. Law Director Mike Johnson said he contacted the Health Department, after being informed of the problem by Councilman Joel Day, who contacted the Police Department to have junk cars removed from the property, and all this information will be forwarded to the Police Department. Mr. Johnson informed Mr. Foust to contact the police or fire department immediately when he sees these violations being committed.

William Walker, 411 W. 7th St. Dover, President of the Local NAACP, thanked the administration for addressing the responding to a request that the city attempt to hire more minorities. Mr. Walker asked if there are maps posted which outline the areas within the city that fall under the guidelines of the CDBG criteria. Service Director Gary Espenschied told Mr. Walker that maps are in his office at General Services.

Ella Slough, 616 Sandpiper, S.E., New Philadelphia, said the property at 224 Ashwood Lane N.W. is a disgrace and something needs to be done immediately. The property next door is also in disrepair. She reported a large hole on West High Ave. in front of the former Ohio Power office, and also one on 2nd St. N.W. Ms. Slough asked who is responsible to maintain properties below street level. Law Director Mike Johnson said he owns the particular property that Ms. Slough referred to, and it has been taken care. He said passersby throw their trash down the steps, and he will check on it periodically to see that it is cleaned up.
