MAYOR'S REPORT/REQUESTS ...MAYOR JOEL B. DAY

Mayor Day had the following report:

- Urge Council to Adopt the City's 2018 Budget Tonight: Mr. President I request that Council suspend its rules and adopt Ordinance 27-2017, which would enact the City's 2018 budget. I would like to thank Auditor Gundy, Finance Committee chair Lautenschleger, members of the Finance Committee and all City department heads for their help in crafting the budget. It reflects our cautious approach to 2018 as we deal with the uncertainty resulting from the Ohio Legislature's changes in our income tax law and the outcome of lawsuits that hopefully reverse those changes.

- Farewell to Councilman Darrin Lautenschleger: I would like to express my gratitude to Councilman Lautenschleger for his service to our City and his commitment to the

improvement of the New Philadelphia community. His accomplishments should serve as a standard for Council members. I wish him the best in his future endeavors.

- 2017 was a Productive Year for New Philadelphia City Government :2017 was not without its challenges. But overall, this has been another productive year for New Philadelphia city government. For example, with the help of City Council, we were able to take big strides toward developing a new recreation economy, complete major infrastructure projects at the water plant and airport, open a new fire station, and complete a master plan for the new Southside Community Park. The year's accomplishments would not have been possible without the guidance and knowledge of Service Director McAbier and the efforts of his team of Service Department supervisors and administrators. And thanks to the leadership of Police Chief Goodwin, Fire Chief Parrish, Health Commissioner Ionno, and Municipal Court judge Von Allman, our City is now fully engaged in developing solutions to opioid addiction that includes intervention and treatment for addicts, and the conviction of drug dealers. I would be remiss if I did not include the role Law Director Fete has played in making 2017's achievements possible. His authoring of legislation and legal advice has been essential in the actions taken by the Administration and Council. Lastly I would like to thank our entire city workforce for their efforts this year. They have kept our neighborhoods and business districts safe, our infrastructure in good repair and have improved our processes and customer service. A full accounting of my Administration's accomplishments in 2017 will be made when I issue my second State of the City Report early next year.

Mr. Holland had the following comment:

Darrin, I have the opportunity unlike most everyone else to continue working with you on the hospital public relations committee that reports to the hospital board. I certainly want to acknowledge your assistance in helping me get adjusted when I came on Council. Your advise has been truly very valuable.

Mr. Zucal had the following comment:

In addition to being my brother-in-law I found Councilman Lautenschleger to be a quality professional and a great public servant and I say that with somewhat of a bias, but I also know that he did his very best to serve each and every one of those constituents, not just in his ward but across the entire City with dignity, class, and their best interests at heart. Having talked with him on different occasions prior to my coming on Council he was able to tread through some pretty deep waters at times with the Walgreens situation, divided among many people in New Philadelphia, and as a member of Council he was able to navigate through that and to listen to feedback from a lot of different citizens. I know back in 2010 we had some of the same experiences . There was a lot of public discussion about where the airport was headed as well, and again his leadership allowed us to move forward in a productive manner as well. I think what Darrin brought to City Council that cannot be duplicated in any way, shape, or form, is his knowledge of both public and private sector service from a marketing and public relations standpoint. We've been able to know that, to recognize and understand the public policy and how that impacts City government with his expertise of years of service at the Muskingum Watershed, his relationship as a former member of the Times Reporter. He gets a lot of different pieces that go into making a Councilmember very, very effective. Last but not least I appreciate his support as we move forward with some challenging issues in the past several years including trying to take steps to move the salary scale forward, his undying and unwavering support of the new fire department, and again just tremendous leadership he showed as we had a tremendous paradigm change in how we do business from the finance committee perspective. I moved here permanently in 1990 when I started at the Times Reporter as a reporter and my first experience in dealing with a member of the New Philadelphia City was the Police Department and that was Chief Detective Greg Popham. He won't remember this but this is still one of my favorite stories of all time. I was filling in, picking up police reports one morning on the first snow of the season. When I got there he was kind of chuckling because I read this report about a robbery that they had foiled, well I wanted to find out more. They asked me to come inside, he was trying to figure out who I was. He sat down with me and as I started asking a few questions he said "let me tell you what happened, we had a guy rob a local convenience store and he got away on bicycle. Our detective staff starring Detective Popham followed the bicycle tracks all the way to the gentleman's front door. They knocked on the door. The guy opened the door and said "how did you know it was me?" That was the first story I got on page 1 and I was thrilled to death.

We won't have the authority to spend money.

Mr. Lautenschleger had the following response:

I think the action to not suspend the rules and the votes that did that show a reckless disregard for the citizens of the City of New Philadelphia. I think those items should have been discussed well in advance. That budget does not show a fiscal disregard for the citizens or for the City. I am hugely disappointed. I don't know what to tell you but you better start thinking about what you're going to do because if you want to start putting together meetings I'm not sure there's going to be enough of a quorum to pass a budget. You will not have fire services, you will not have police services effective midnight, January 1.

Mayor Day had the following comment:

Mr. President I will say, point of order, any of the Members can ask that this be reconsidered during this meeting.

President of New Philadelphia City Council Sam Hitchcock had the following reply:

It has to be someone who has voted against it. Someone who has voted against that can call for a reconsideration.

Mr. Holland had the following reply:

Being one of those that voted against it, my concern was that the Mayor has acknowledged that he doesn't know what's going to happen at State level. Mr. Lautenschleger as Finance Chief acknowledged the same thing and so has the Auditor. I think there's an opportunity to do a temporary appropriation which would cover the first 90 days of the coming fiscal year.

President of New Philadelphia City Council Sam Hitchcock had the following comment:

The State does provide for a temporary appropriation for three months.

Mr. Zucal had the following comment:

Right but we have to have an operating budget to go from.

Mr. Holland had the following comment:

To not have any idea what's going to happen at the State Level doesn't seem logical to me to approve an operating budget.

With respect, my no vote was not done with any reckless regard. My concerns have been brought to the table for months, and I mean months, verbally, and in writing, and in emails. They have been disregarded on many levels. I have addressed my concerns, and I had a lot of concerns about this budget.

Mr. Zucal had the following comment:

What we have to recognize is that we're dealing with a working document, that it is not, just by passing the budget, it does not say that those same concerns cannot be addressed throughout the process as we streamline that and make appropriations on all ends. Temporary appropriations throughout the course of the year. We are able to change line items throughout the course of the year as we seem fit, so that we're able to provide the services that we have. As the Auditor stated, those numbers don't mean that the cash is there and you have to spend it all. We're not going to go through an entire operating budget the first quarter of the year. What it is going to allow us to do is provide the citizens what we need to provide. By saying we pass it tonight it doesn't mean that can't change. It doesn't mean it can't be reviewed. So again I thank Mr. Holland

and asking for reconsideration of that because again that allows us at least to do business and I think we're all in agreement that we need to monitor the progress of where we're at, we need to see what happens at the State level, the local level, and adjust that budget accordingly, just like your budget at home. Just because you set it doesn't mean you have to spend it.

Mr. Ricklic had the following comment:

As a former superintendent of the City and a Councilperson, I know Beth Gundy. If she does not have the funding she's not going to approve a P.O. So the spending will not be there to put us in a deficit. That would be something she would definitely discuss with the Mayor and Council I'm sure. So to keep us from providing no services to our Citizens and putting us in a bigger liability I do recommend that we do pass this and we do keep an eye on it and we do get numbers as our income, not only from our income department, the other income; the water, the sewer, the garbage, the courts, the police. We need to know what those numbers are, yes, especially in these times that we don't know what the real numbers are going to be. I do put my faith into our administration not to put us in deficit spending and put out p.o.s if we can't cover them with cash.

Mr. Maurer had the following comment:

I'd like to thank Mr. Holland for his comments and his reconsideration. I've sat through a few budgets over the years and any budget is scary. We don't know what the state's doing. 99% of the municipalities don't know what the state's doing. We're talking about simplifying a budget.
