The dollar figure is at retail numbers but the Mayor had asked for a number. I still believe that the actual cost would be \$300 plus.

# Service Director McAbier had the following comment:

All this does is put us on a map showing the Tuscarawas River and a couple of points in the Coniglio and Carlisle Property. This will cost us nothing. All this does is show support so we can go out and get a grant. So, with the passing of this legislation. I would like to see it pass on the 1st Reading tonight and pass on emergency.

# Mayor Day had the following comment:

Having us part of this map also opens some more opportunities for us to obtain grant money to do improvements along our stretch of the river.

# Mr. Zucal had the following comment:

The good news about this is, to a degree what we're trying to do with the actual trails would be the compatibility piece that we'll be able to highlight both those together. It could be very beneficial because people from out of town will realize they can bike one day and kayak or canoe the next day.
