

**RESOLUTION 11-2016**

A RESOLUTION BY THE COUNCIL OF THE CITY OF NEW PHILADELPHIA, OHIO TO COMMEND WINNIE WALKER FOR HER FOURTEEN (14) YEARS OF SERVICE AND DEDICATION TO THE CITY OF NEW PHILADELPHIA AS COUNCIL-AT-LARGE AND AS A TIRELESS ADVOCATE FOR PERSONS WITH DISABILITIES. AMONG ACCOMPLISHMENTS, MS. WALKER MADE SURE THE CITY OF NEW PHILADELPHIA WAS HANDICAPPED ACCESSIBLE AND FOLLOWED THE GUIDELINES OF THE AMERICANS WITH DISABILITIES ACT. MS. WALKER ALSO CO-FOUNDED THE SOCIETY FOR EQUAL ACCESS AND WAS A MOTHER'S MARCH CHAIRMAN FOR THE MARCH OF DIMES FOR TEN (10) YEARS. MS. WALKER SERVED ON CITY COUNCIL FROM JANUARY 1, 1996 THROUGH DECEMBER 31, 2001 AND FROM JANUARY 1, 2008 THROUGH DECEMBER 31, 2015 AND DECLARING AN EMERGENCY.

WHEREAS, WINNIE WALKER HAS NOW RETIRED FROM THE CITY OF NEW PHILADELPHIA, AND


