

AMENDED RESOLUTION NO. 34-2016

A RESOLUTION BY THE COUNCIL OF THE CITY OF NEW PHILADELPHIA, OHIO TO ENACT A PAY INCREASE FOR DESIGNATED NON-BARGAINING UNIT EMPLOYEES AND ELECTED OFFICIALS, LISTED HEREIN, IN THE AMOUNT OF 3.0% SUBJECT TO THE TERMS AND CONDITIONS LISTED HEREIN, AND DECLARING AN EMERGENCY.

WHEREAS, the City of New Philadelphia in order to retain and encourage qualified individuals at all levels of public service has determined that the following positions should receive a 3.0% pay increase retroactive to January 1, 2016, and

WHEREAS, the following non-bargaining unit employees that are to be subject to this pay increase include: Safety Director, Information Systems Specialist, Health Commissioner, Director of Nursing, Environmentalist, Office Manager, General Services Superintendent, Assistant General Services Superintendant, WWTP Superintendent, Cemetery Superintendent, Park Superintendent, Assistant Park Superintendent, Police Chief, Mayor's Executive Assistant, Custodian, Safety Forces Secretary, Service Director, Water Superintendent, Assistant Water Superintendent, Income Tax Administrator, Assistant Custodian, and Parking Control Officer; and

WHEREAS, the following elected positions that are to be subject to this pay increase include: the Auditor, Treasurer, Law Director, and Mayor; and

WHEREAS the City of New Philadelphia has determined that a salary scale is a priority in order to continue to retain and encourage qualified individuals at all levels of public service, and maintain fiscal responsibility, there should be no further pay increases until a salary scale for both non-bargaining unit employees and elected officials has been adopted by the City of New Philadelphia.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF NEW PHILADELPHIA, OHIO:

SECTION 1. The Council of the City of New Philadelphia, Ohio does hereby enact a 3.0% pay increase retroactive to January 1, 2016 for the following Non-Bargaining Unit Employees: Safety Director, Information Systems Specialist, Health Commissioner, Director of Nursing, Environmentalist, Office Manager, General Services Superintendent, Assistant General Services Superintendant, WWTP Superintendent, Cemetery Superintendent, Park Superintendent, Assistant Park Superintendent, Police Chief, Mayor's Executive Assistant, Custodian, Safety Forces Secretary.

SECTION 2. The Council of the City of New Philadelphia, Ohio does hereby enact a 3.0% pay increase retroactive to January 1, 2016 for the following elected positions: Auditor, Treasurer, Law Director.

SECTION 3. The Council of the City of New Philadelphia, Ohio does hereby enact a 3.0% pay increase effective the date this Resolution is signed into law for the following Non-Bargaining Unit Employees: Service Director, Water Superintendent, Assistant Water Superintendent, Income Tax Administrator, Assistant Custodian, and Parking Control Officer.

SECTION 4. The Council of the City of New Philadelphia, Ohio does hereby enact a 3.0% pay increase effective the date this Resolution is signed into law for the following elected positions: Mayor

SECTION 5. There shall be no further pay increases for either non-bargaining unit employees or elected officials until the City of New Philadelphia has adopted an official pay scale for the same.

SECTION 6. This Resolution is hereby declared to be an emergency measure and its immediate passage is necessary in order to preserve, protect and maintain the health, safety and welfare of the citizens of the City of New Philadelphia, Ohio.

SECTION 7. This Resolution shall take effect and be in force immediately upon its passage and approval.


