

RESOLUTION 6 - 2016

A RESOLUTION BY THE COUNCIL OF THE CITY OF NEW PHILADELPHIA, OHIO TO COMMEND AMY GILLAND FOR HER 16 PLUS YEARS OF SERVICE AND DEDICATION TO THE CITY OF NEW PHILADELPHIA AS DATA PROCESSOR FROM MARCH 1998 THROUGH MAY 2008 AND ASSISTANT SERVICE DIRECTOR FROM JULY 2008 THROUGH DECEMBER 31, 2015 AND DECLARING AN EMERGENCY.

NOW, THEREFORE BE IT RESOLVED BY THE COUNCIL OF THE CITY OF NEW PHILADELPHIA, OHIO:

SECTION 1. THE COUNCIL OF THE CITY OF NEW PHILADELPHIA DOES HEREBY COMMEND AMY GILLAND FOR HER SERVICE AND DEDICATION TO THE PEOPLE OF NEW PHILADELPHIA, OHIO AS DATA PROCESSOR AND ASSISTANT SERVICE DIRECTOR FOR THE CITY OF NEW PHILADELPHIA, OHIO.

SECTION 2. THIS RESOLUTION IS HEREBY DECLARED TO BE AN EMERGENCY MEASURE AND ITS IMMEDIATE PASSAGE IS NECESSARY IN ORDER TO PRESERVE, PROTECT AND MAINTAIN THE HEALTH, SAFETY AND WELFARE OF THE CITIZENS OF THE CITY OF NEW PHILADELPHIA, OHIO.

SECTION 3. THIS RESOLUTION SHALL TAKE EFFECT AND BE IN FORCE IMMEDIATELY UPON ITS PASSAGE AND APPROVAL.
