

ORDINANCE NO. 8-2024

AN ORDINANCE BY THE COUNCIL OF THE CITY OF NEW PHILADELPHIA, OHIO TO AMEND THE CITY'S CODIFIED ORDINANCES FOR THE PURPOSES OF CHANGING THE TITLE OF "BUILDING INSPECTOR" TO "CODE ADMINISTRATOR" AND UPDATING THE DUTIES OF THE SAME, AND DECLARING AN EMERGENCY.

WHEREAS, the Council of the City of New Philadelphia, Ohio, at the request of the Mayor, desires to change the title of Building Inspector to Code Administrator and to update the duties of the position to more accurately reflect the current duties and responsibilities of the same; and

WHEREAS, the Codified Ordinances of the City of New Philadelphia need to be amended to affect this change in title and duties.

NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF NEW PHILADELPHIA, OHIO, THAT:

SECTION 1. Codified Ordinance Chapter 166 is amended to read as follows:

CHAPTER 166  
Code Administrator

SECTION 2. Codified Ordinance 166.01 is amended as follows:

166.01 ESTABLISHED

Council does hereby establish the full-time position of Code Administrator to enforce the Zoning Codes, Housing Codes, and the International Property Maintenance Codes within the City of New Philadelphia, Ohio.

SECTION 3. In each of the following listed Codified Ordinance Subsections, the title of "Building Inspector" shall be amended and changed to "Code Administrator":
