## RESOLUTION NO. 10-2021

A RESOLUTION BY THE COUNCIL OF THE CITY OF NEW PHILADELPHIA, OHIO TO AUTHORIZE THE MAYOR TO ENTER INTO AN AGREEMENT WITH THE GOSHEN TOWNSHIP TRUSTEES FOR FIRE AND EMERGENCY MEDICAL SERVICES FROM THE CITY OF NEW PHILADELPHIA WITHIN GOSHEN TOWNSHIP, OHIO, TO CONTINUE QUARTERLY INVOICES, AND TO HAVE THE NEW PHILADELPHIA FIRE DEPARTMENT BE RESPONSIBLE FOR ANY ADDITIONAL INVOICES, AND ALLOWING ANY ASSETS RECOVERED TO REMAIN THE PROPERTY OF THE NEW PHILADELPHIA FIRE DEPARTMENT FOR THE CALENDAR YEARS 2022, 2023, 2024, 2025, and 2026, AND APPROVING A MEMORANDUM OF UNDERSTANDING APPROVED BY GOSHEN TOWNSHIP TO ADUST THE TERMS AND CONDITIONS OF 2021, AND DECLARING AN EMERGENCY.

NOW, THEREFORE BE IT RESOLVED BY THE COUNCIL OF THE CITY OF NEW PHILADELPHIA, OHIO:

SECTION 1. The Council of the City of New Philadelphia does hereby authorize the Mayor to enter into an agreement with Goshen Township Trustees for fire protection services from the City of New Philadelphia within Goshen Township, Ohio as follows:

For the Calendar Year 2022	\$180,000.00
For the Calendar Year 2023	\$180,000.00
For the Calendar Year 2024	\$180,000.00
For the Calendar Year 2025	\$180,000.00
For the Calendar Year 2026	\$180,000.00

SECTION 2. The Council of the City of New Philadelphia does hereby approve the Memorandum of Understanding to approve and adjust the terms and conditions of the final year, 2021, of the previous contract, and the new terms that shall be implemented as of January 1, 2021 are as follows:

For the Calendar Year 2021 \$180,000.00

SECTION 3. The Council of the City of New Philadelphia does hereby approve the terms in the agreement that requires a quarterly schedule for invoicing, and any additional invoicing for services being the sole responsibility of the New Philadelphia Fire Department, and allowing any assets recovered to remain the property of the New Philadelphia Fire Department.

SECTION 4. This Resolution is hereby declared to be an emergency measure and its immediate passage is necessary in order to preserve, protect and maintain the health, safety and welfare of the citizens of the City of New Philadelphia, Ohio.

SECTION 5. This resolution shall take effect immediately upon its passage and approval.
