## **RESOLUTION 5-2024**

A RESOLUTION BY THE COUNCIL OF THE CITY OF NEW PHILADELPHIA, TUSCARWAWAS COUNTY, OHIO, AUTHORIZING AND DIRECTING THE MAYOR TO SUBMIT A GRANT APPLICATION WITH THE OHIO DEPARTMENT OF NATURAL RESOURCES, THROUGH THE OHIO RECREATIONAL TRAIL PROGRAM FOR ASSISTANCE FOR PUBLIC RECREATION PURPOSES, AND ONCE THE GRANT OFFER IS RECEIVED, FURTHER AUTHORIZATING THE MAYOR TO EXECUTE THE GRANT CONTRACT AND ALL RELATED DOCUMENTS AND AUTHORIZING THE CITY OF NEWPHILADELPHA TO ACCEPT ANY GRANT MONEY AWARDED TO THE CITY OF NEW PHILADELPHIA, AND DECLARING AN EMERGENCY.

WHEREAS, the State of Ohio, through the Ohio Department of Natural Resources, administers financial assistance for public recreation purposes, through Recreational Trails Program (RTP) and/or the Clean Ohio Trails Fund (COTF)

WHEREAS, the Council of the City of New Philadelphia, Ohio desires financial assistance under the RTP Program,

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of New Philadelphia, Ohio as follows:

SECTION 1. That the City of New Philadelphia approves filing an application for Recreational Trail Funds financial assistance

SECTION 2. That the Mayor, Joel B. Day, is hereby authorized and directed to execute and file an application with the Ohio Department of Natural Resources and to provide all information and documentation required to become eligible for possible funding assistance.

SECTION 3. That the City of New Philadelphia does agree to obligate the funds required to satisfactorily complete the proposed project and become eligible for reimbursement under the terms and conditions of the Recreational Trail Program.

SECTION 4. This Resolution shall take effect and be in force immediately upon its passage and approval.
