MAYOR'S REPORT/REQUEST......MAYOR MICHAEL TAYLOR

The Mayor addressed Council on the following:

Mayor Taylor reported the following:

- The Mayor reported that the New Philadelphia City Health Board received the Health Commissioner's, Keith Eames, resignation for retirement effective May 31, 2011. This position, at the direction of the Board of Health has been advertised and the Board will move forward towards filling this upcoming vacancy.
- The Mayor announced that he will be meeting with AFSCME union representatives later this week to discuss wages for 2011 and 2012.
- The Mayor announced that Constellation New Energy has mailed out the gas aggregation solicitation letter for the 12 month fixed rate of \$5.89 per Mcf. The Mayor said that he will follow up with them towards the end of April to determine what citizen interest they had in this locked in 12 month rate.
- The Mayor announced that April is Safe Digging Month and he reminded all citizens to call 811 before they dig which is required to avoid damaging any underground wires, pipelines or cables. The Mayor said that the season for outside building projects is beginning and this is an important first step.
- The Mayor congratulated and welcomed Scott Robinson as the new President of the Tuscarawas County Chamber of Commerce. The Mayor said that Scott has been an exemplary leader for the last 15 years of the United Way of Tuscarawas County and will be a valuable and positive face for the Chamber. The Mayor said that he looks forward to working with him.

The Mayor yielded the floor to Mr. Tom Farbizo, Airport Commission Chairman, who addressed the Council Members on the required 2010 Annual Report for Harry Clever Field

Ms. Rowland gave the President of Council, Joel Day packets of information she had collected on Hydraulic fracturing or fracking (a means of natural gas extraction employed in deep natural gas well drilling) to be distributed to Council Members and the Administration. Ms Rowland addressed council on that subject and requested council review the information she had provided.

After listening to Ms. Rowland's concern President Joel Day requested that the Service Director, Jim Zucal and the Water Superintendent, Kelly Ricklic do research and report back "if deep natural gas well drilling poses a threat to our water supply."

Christine Giumenti, 415 West 12th Street, Dover, Ohio 44622

Ms. Giumenti addressed council on her concerns on the drilling in Central Ohio. Both ladies were concerned with the safety of our water, air pollution and the effects of the chemicals that are used in deep natural gas well drilling. President Joel Day thanked both ladies and stated that we appreciated the information and that we would look further in to this issue.
