ADMINISTRATIVE REPORTS:

MAYOR'S REPORT/REQUEST......MAYOR MICHAEL TAYLOR

The Mayor held his third annual voluntary employee meeting at Tuscora Park Pavilion.

Items discussed: The availability of a new voluntary dental insurance policy for any full time employees at their own expense. Reviewed the employee wellness incentive program for the coming year, highlighted accomplishments from 2009 and reported on projects planned for 2010. The employee meetings create an opportunity to share information with all departments.

Recently, Mayor Taylor attended the ground breaking for the new service center for the Tuscarawas County Board of Developmental Disabilities at their Commercial Avenue SW location. The new building in their campus will provide efficiencies of operations for clients and employees and will be a welcome addition to our city. As part of this project, two locations in New Philadelphia will close. The employees from those locations will move to the new central facility.

Mayor Taylor worked with the AFSCME Clerical Union and they have approved the changes to the previous tentative agreement regarding the wage increase being reduced from 1 ½ % to 1 % for 2010. The Mayor encouraged council to pass this legislation this evening to complete the bargaining contract process for all unions. This will not be possible because of the 2 members absent. The Mayor requested a Special Meeting of Council to be held Monday, April 19, 2010 at 6:30 PM in Council Chambers. The purpose of this meeting only is to take action on the following:

- Ordinance 8-2010 (Traffic Signal Project),
- Resolution 15-2010 (Paving Project for West High Avenue), this resolution needs to be passed before April 21st 2010.
- Resolution 16-2010 (to adopt the Clerical Tentative Agreement),
- Resolution 17-2010 (to reject the Clerical Tentative Agreement)

SERVICE DIRECTOR MR. JIM ZUCAL

Mr. Zucal announced before the next city council meeting of April 26, 2010 Jeannette Wierzbicki, P.E., of W.E. Quicksall & Associates, Inc., will have the second public hearing for the 2011 Construction Year CDBG Project.

The housing review team met on March 30, 2010 visited, reviewed and sent out letters to owners of 4 dilapidated structures in the city.

The Service Director coordinated 2 litter clean ups in the city with the Tuscarawas County Office of Litter and Recycling. One clean up was last weekend on the south side interchange area near Commercial Avenue and South Broadway The other will be this weekend at west-end interchange.

The city's street department employees continue to sweep streets and are now using hot mix to patch pot holes If you have any paving requests please have them to the Service Director, as the memo stated, by this Friday.

Colleen asked what time Jeannette will be having the hearing. Mr.Zucal said Jeannette typically schedules her meeting briefly before ours around 7:00 PM; it is usually about a 10 to 15 minutes meeting before the Council Meeting.

Judge Edward O'Farrell gave us a dead line to meet. The Law Director is pushing to get the lawyers and everything taken care of and come back with a final agreement for city council.

Mr. Michael Johnson reviewed the Rhodes Case with our attorney in Cleveland. We anticipate a ruling on that the public records case. We expect that to happen in the very near future but we cannot put a date on it.

The mayor, the service director, engineer and law director met with Scurlock Construction.

They are trying to get some issues taken care of, that projects is completed, but there are some other issues that need addressed We met with them today informally. We will have information for council by the next regular meeting.

The Law Director apologized to Ms. Walker as he did not have her indigent burial paper work done. He has been working on it and he will try to have it ready by the next meeting so she will be able meet with her committee on it.

We probably have 6 foreclosures we are involved in because of the grants through the federal and state that Mr. Danzo handles. The Law Director has been handling some mediation on those, working with the home owner and the mortgage companies to get them all resolved. It is all favorable, the land owners can keep their properties and keep paying..

The Law Director is working to get that all taken care of and to do it with the city's position that we are not in business to take any ones home away from them We are being cooperative in working with everyone.
