ADMINISTRATIVE REPORTS:

MAYOR'S REPORT/REQUESTS....MAYOR DAVID JOHNSON

The Mayor addressed the following:

- o The Mayor reported that he met with AEP Energy. AEP Energy is the cost saving arm of AEP.
- o The Mayor met with Tony Danzo about the changes in the CHIP Program.
- o The Mayor marched in the Memorial Day Parade and participated in the program on the square immediately following the parade.
- o The Mayor conducted a lot of meetings with staff members in the last two weeks.
- o The Mayor attended a demonstration on "Meth Labs" at Tuscora Park presented by the Holmes County Sheriff's Department.
- o Mayor Johnson met with IAFF #1501 (Fire) Union.
- o The Mayor reported he gave his first interview with TV 2 for a new show that they are developing.
- o Mayor Johnson attended the monthly Park Board Meeting. Attached to the Mayor's Report was the press release dated May 29th, 2014 to all area media outlets from the Mayor in regard to the City of New Philadelphia Parks are a SMOKE FREE AREA. (Quaker Stadium has been non-smoking for quite a few years.)
- o The Mayor also viewed the progress of the paving and also several problems throughout the City.

Comments from Councilpersons John Zucal and Mrs. Ramos:

Does that include e-cigarettes?

The Mayor replied:

We did not go that far. That is a debate for another day.

SERVICE DIRECTOR.....MR. JAMES ZUCAL

The Service Director reported on the following:

- Service Director reported on the paving project for this year.
 - Newton asphalt was the bidder for the project. They have started some full depth repair on Mill Avenue around the Mall
 - As in the paving list that he passed out to everyone in Council, We are going to focus on doing those repairs full depth you'll see some heavy patches out there in those areas we are going to come back later and do some overlay you'll see a significant portion of Mill Avenue around the Mall and the Buehler's area about 90 % of that paved.
 - Mr. Zucal thinks that is going to be a major upgrade for our traveling public
 - Also working on areas throughout the City as he provided to you on the list. "You are looking at areas that significantly needed the repair. By going deeper than what we typically do not just putting down asphalt. We are milling, replacing, and coming back later to do the overlay. When it is all done with that and the patching program, you will see the City streets in good condition."
 - Service Director talked on Oak Shadows Phase IV.

Mr. Zucal announced that with us this evening is Mr. Bob Martinelli and Attorney Greg Miller. As a project in Oak Shadows Development, assigned to Chairperson Mrs. Ramos of the Zoning and Annexation Committee. Mr. Zucal announced he is in support of that project. The REM Construction Group did provide the City with an irrevocable letter of credit which is in Chapter 1121 which complies. Mr. Zucal met with the Law Director about that Mr. Fete wrote an opinion in support of that back in the information that we needed for the permission to do so. Mr. Zucal is in support of their project the City utilities are there. Mr. Zucal is asking if at all possible, to expedite that process. It is a benefit for the City. There are only good things to gain by letting that development proceed, letting folks buy lots and provide income to the City.
 - Service Director talked a little about the North Broadway/Wabash Avenue Waterline Replacement Project. Mr. Zucal did give the Council President a letter requesting that he forward it to the proper committee. The Service Director would like to see that moved on, as we need to bid that publically as it will be over \$50,000. (That will loop the water line and add some significant pressure increases in that area for safety.)
 - Service Director reported that the Assistant Service Director, Amy Gilland is back to work. She was on Maternity Leave. Ms. Gilland had a baby boy. Service Director announced that she and her Baby Boy are doing fine. Ms. Gilland's main focus is high grass letters which they have addressed over 45 complaints in the last two weeks. That is a major problem in the City; we are seeing more homes that are vacant and nobody mowing the grass. We are taking and fielding those calls and following the code. If we need to, we are contracting the mowing and putting a lien on the taxes.
- Mayor Johnson requested an Executive Session after the Legislation for purchase or sale of property; and to consider appointment, employment, dismissal, promotion, and compensation of a public employee or official.

SAFETY DIRECTOR.....MR. GREG POPHAM

Mr. Greg Popham reported the Police Department received a legal notice from the Civil Service Commission to administer an entrance examine to establish an eligibility list. The test will be July 23rd, 2014 at 6:00 PM at Tuscora Park.

Question from Councilperson Mrs. Cheryl Ramos:

(In regard to the Fire Department Report we received from the Fire Chief.)

“We have a year to date total on overtime paid out of 2,429 hours how much is that in dollars?”

Fire Chief replied:

“Averaging the over time rate from Captain to Step 1 Firefighter that would be \$93,200.73.”

TREASURERMR. AARON HILLYER.....NO REPORT

President of Council, Sam Hitchcock announced that the Treasurer is absent.

LAW DIRECTORMR. MARVIN FETE

The Law Director reported the following:

- Over the past couple of weeks:
 - He awarded the Legal Secretaries Position, based on the committee process allowed by the AFSCME Clerical Contract to Ms. Rachel Ciereszewski. She has been our assistant in there for a number of years and we are pleased she is the one. (She was the only bid.)
 - In terms of filling that Assistant Position we have not made a decision on that it will be up to the Law Director. In communicating with the Prosecutors and Ms. Ciereszewski we discussed she wants to get that office organized. “The only time I foresee someone in there is if she is gone. We are looking where we can save money in that regard.”
- Mr. Fete met with the Service Director and issued two legal opinions with regards to the Oak Shadow Phase IV there are people here to address that this evening.
- Prepared Infrastructure Bank Agreement. It is one of our legal requirements from ODOT for completing the West High Widening Project.
- Met with Fire Chief to draw up a contract for fire protection with the York Township. That was completed. The contract just has to run past the Fire Chief and eventually have Council take a look at that.
- Filed another motion to declare value of vest title on one of our last hold-outs
 - With regard to the West High Widening Project. The Law Director has handled 6 cases in the Common Pleas Court on the West High Widening and we had to file to get the price settled. We are asking for a Default Judgment because they did not offer an answer to our complaint the court would just go ahead and award what was originally offered.

BOARD/COMMISSION REPORTS:

PLANNING COMMISSION.....MAYOR DAVID JOHNSON

Mayor Johnson announced the Planning Commission should have a meeting on Tuesday June 10th, 2014 at 1:00 PM in Council Chambers but there are no items.

BOARD OF ZONING APPEALS.....MR. JAMES ZUCAL

Mr. James Zucal announced the Board of Zoning Appeals is scheduled to meet Tuesday, June 10th, 2014 at 5:00 PM in Council Chambers but at this time there are no variance requests.

AIRPORT COMMISSION.....MR. JOHN ZUCAL

Mr. Zucal announced that the next meeting of the Airport Commission will meet Tuesday June 10th, 2014 at 6:00 PM in the Airport Meeting Room. Mr. Zucal announced we do have with us this evening Mr. Tom Farbizo, who will be speaking, representing the Quaker Digital Academy Foundation and their tax exempt status.

PARK BOARD.....MR. DARRIN LAUTENSCHLEGER

Mr. Lautenschleger announced since our last meeting the New Philadelphia Park Board Meeting was rescheduled and held Wednesday May 28th, 2014 at 7:00 PM at the Tuscora Park Office.

- o A couple highlights of the meeting, as the Mayor reported, the Park Board voted unanimously to enact a no smoking ban on all park facilities in the City of New Philadelphia; which takes in Tuscora Park, Southside Community Park, Waterworks Ball Fields and Skate Park.
- o Mr. Lautenschleger reported on the training provided by the Park for its staff on methamphetamine labs. Meth labs are being more and more prevalent, unfortunately. Mr. Lautenschleger commended Rod Miller Park Superintendent for the Outstanding program, from a safety stand point especially.
 “If you have seen some of the police logs and news stories in recent weeks some of the items are being disposed of in residence trash cans there is a tremendous safety issue. In fact, the Mayor and Mr. Miller reported to us that severe injury and even death could be caused by encountering some of those items through the training they were provided.”
 (An outstanding move on their part.)
- o Next Park Board Meeting will be June 25th, 2014 7:00 PM at Tuscora Park Pavilion the Key portion of that meeting will be Park Board Members are going to contact and invite some of their key stake holders (People who use the Southside Community Park)to bring them in and sit down and start gathering information for the development and contracting with a firm to prepare a Master Plan for Southside Community Park.

HEALTH BOARD.....

Ms. Cox reported

At the May 14th, 2014 Health Board Meeting Lyme Disease was a topic of discussion as a Continuing Education Program. Ms. Cox announced that on each Council desk was information on Lyme Disease Prevention.

Ms. Cox requested each person read the information.

STANDING COMMITTEE REPORTS:

FINANCE COMMITTEENO REPORT

SALARY COMMITTEEMR. JOHN ZUCAL

Mr. Zucal announced that he wanted to bring to the attention of Members of City Council, the Administration and our Guests here tonight what he believes is a very important piece of legislation that is currently in Columbus with us right now.

House Bill 487 you may know as the Mid-biennium Budget Review. And House Bill 483 which again is the Mid-biennium Budget Review Appropriations Legislation.

Included within House Bill 483 is language from Senate Bill 52. Senate Bill 52 has never received a Committee for floor vote in the Senate.

Essentially what Senate Bill 52 would do is it would prohibit Boards of Education and Local Government Officials from filing appeals on property values for real estate properties within their taxing district.

Essentially what it does is those entities that own property especially commercial property they are always able to question the evaluation on that property what it is appraised at. This would limit Boards of Education and Municipalities from having any appeal process on the opposite end of that. Therefore we would be in an unfair playing field. In some cases asking some taxpayers to subsidize taxes of those who are able to file such appeals. This is supported by the Ohio Municipal League, the Ohio School Board Association, the Ohio Township Association, the Buckeye Association of School Administrators and the Ohio Association of School and Business Officials.

They have drafted a letter to keep favor of the President of the Ohio Senate asking that any language that is part of Senate Bill 52 be removed from House Bill 483 or 487 in the interest of honesty, integrity, and equity when it comes to the appeals process.

SAFETY HEALTH & SERVICE COMMITTEE.....MR. ROB MAURER....NO REPORT

PUBLIC WORKS & ECONOMIC DEVELOPMENT COMMITTEE ...MR. DARRIN LAUTENSCHLEGER

Mr. Russo’s Concern was RITA

Mr. Russo distributed some information on RITA for Council to review.

Mr. Russo reminded everyone that the Mayor had said there would be no jobs lost if we should eliminate the Income Tax Department and farmed this out to RITA.

Mr. Russo pointed out that “this would actually cost us money and we would not be saving any money” and also “I have some information I got a hold of from the internet from the Cleveland Plain Dealer.”

Which was a fiasco that RITA had with a problem with their web site that people were not able to log on and file their taxes. (20,000 people) What I am gathering is with RITA we would be charged 3% of the earnings coming in and that would add up to about \$150,000.

With us not eliminating any positions from the Income Tax Department, we would actually be losing money. Secondly: with what RITA claims that they can also bring in enforcements of collection.

Mr. Russo was talking to the Income Tax Department and was informed that currently for the non filing of taxes is \$25.00 and a 1% penalty per month for late fee.

His suggestion as a citizen of New Philadelphia don’t go with RITA,

Write some legislation to increase the penalty to 10% per month for late fee for not paying your City income taxes.

He also requested that Council not go for a third reading of the Ordinance and just knock it out tonight on the Second Reading.

Comment from the Mayor:

“I never said nobody would lose their jobs.

I said it is my goal to keep anybody from losing their jobs if Council decides to go with RITA.”

Attorney Miller stated he is working with Bob Martinelli in the development of the Oak Shadows Phases out on the hill. We have run into problems this year with the weather and it has put us behind.

We are asking for Councils help in trying to help people who want to buy lots and start building in the City of New Philadelphia. Mr. Miller reviewed the City's Code it does permit the approval of a Plat of lots prior to the actual completion of the lots by posting acceptable instrument to guarantee performance. Mr. Miller met with Service Director Zucal and Law Director Fete who both are in support of trying to put this together. We have an irrevocable letter of credit that has been issued in the City's name for guaranteed performance. We have our Plat in Cheryl Ramos Zoning and Annexation Committee Meeting for next month June 9th, 2014 at 6:30 PM we are asking that will come out and be passed on an emergency Ordinance. There are other steps that we have to go through yet with the county that delays the sale of plots. We have all the utilities in at this point. But still there will be a letter of credit to guarantee performance on behalf of Bob Martinelli. Attorney Miller thinks there track record in the City of New Philadelphia proves itself. Attorney Miller encouraged all to go up to Oak Shadows and see the quality of work that is there. There working with development on West High and Mr. Miller is hoping that Council will work with us on the Plat.

The contract does not state that the money will be used for scholarships.

Mr. Farbizo:

Our sole purpose is for scholarships for QDA students.

Comment from Mrs. Ramos

It doesn't say that in the contract but it is for post-secondary.

Mr. Farbizo:

It is for anybody going for further education.

Comment from Mrs. Ramos:

I wanted to clarify that because 501 c3 can do legally

I wanted to make sure that this was going to scholarships.

The Law Director replied:

I don't feel it needs to be in the contract the purpose of the foundation is what the City is going to get out of it.

The foundation was created to give scholarships it is in their by-laws.

I don't know that we can write a contract that forces them to do a certain thing we are merely subleasing with them as an agency at no cost to the City. And we are going to get 40 % of the revenue and free windows out of it.

That was the purpose of the contract not to control the foundation.

The purpose of the contract was a sublease. And that is what the contract accomplishes.

Councilperson Mrs. Ramos:

The original contract said twelve (12) Energy-efficient windows.

This one says up to twelve (12) Energy-efficient windows.

This lease is for three years and renewable automatically in three years.

Councilperson Mr. Zucal:

All that we are talking about this evening has been covered extensively during the actual meetings of the Airport Commission. We have met and which you are a member of; we have gone over with Mr. Farbizo, Chair of the Airport Commission which is helping to drive this process between QDA, City Council, and the Airport Commission.

Mr. Lanzer has been very active as the Special and Contact Chairperson with this.

We were using the language up to twelve; meaning anywhere from one to twelve windows as there is no guarantee for twelve (12) Energy-efficient windows to be done.

Councilperson Mrs. Ramos:

I was asking these questions to get it out in the air and just clarify it.
